Cecelia Alvarado, a Juvenile Probation Officer (JPO) out of Atascosa County, is being recognized as a Liberty Champion. Cecelia states that she has always wanted to be a JPO, and even has a photo of herself in kindergarten with a badge! She states that she has "the love for Criminal Justice" in her blood, as her father was a police officer and her brother is a Tennessee State Trooper. She enjoys the people she meets in her position, as well as all the wonderful families she is able to help. She states that her greatest accomplishment as a JPO is seeing a child start to believe in themselves. "Once they begin to do that, you see the family dynamic start to change for the better." Her hope for the future of the troubled youth and families within her community is what inspires her daily drive and motivation, and she is rewarded by seeing the smiles on the children's faces when they are praised for doing well.

When asked about her greatest success story, JPO Alvarado recalled "a young man who became involved with my department many years ago. He was a mental health child who was physically abused by his mother and grandmother. Through the years, we developed trust and understanding with each other. He is now a productive member of society – he has his own place, his own vehicle, and is employed. That young man comes to see me at least twice a year." Thank you for sharing your generous spirit…it has made all the difference!

JPO Charles Rice has done an outstanding job working with youth in the Intensive Supervision Program. Although he's been working with youth for about 21 years, 15 of them were served in a live-in, group home setting caring for youth on juvenile probation and in CPS care. Prior to that, he served in the U.S. Army as a Sergeant First Class (E-7). JPO Rice has a strong Christian faith and feels that he was called by God to work with at-risk teens. His relatable experiences have enabled him to understand and connect with the youth and their families. He stated that the most rewarding aspect of his job is when youth actually "get it" and are able to "show you they get it as you see them make changes in their lives".

One major accomplishment JPO Rice recalls is when his encouragements helped a young man change his life. That youth graduated high school; entered college, obtaining a Bachelor's of Science degree; and now works as an assistant teacher in China teaching English. JPO Rice stated that he engages caretakers "calmly, humbly... [and with] empathy [for] their situation." He encourages families to get involved to support the youth and participate in community based programs, such as basketball, mentoring, and community counseling. JPO Rice is always willing to help and exhibits a positive attitude in all he does! The part of the job that he says he enjoys the most is, "Talking with the youth and families to help discover solutions for them to be successful." Liberty Resources is so thankful to work with such an extraordinary probation officer and person! Believing that early intervention with teens greatly impacts their future success, JPO Liebel aims to get them on the right track to limit negative consequences they may face in adulthood. Utilizing many resources to help his families, such as the Liberty Resources Placement Diversion/Family Reunification Program, he makes a positive impact on teens and their families. Currently, he is working with a family where the youth has greatly increased their ability to be successful in the home, school, and community. The youth is working, has increased his relationship with his family, and is doing excellent in school.

What JPO Liebel enjoys most about his job is seeing youth he worked with in the past doing well. He really loves to hear their success stories and see how they have overcome challenges to turn their life around; this is what continues to drive him. JPO Liebel will, without a doubt, continue to impact many youth and their families in the future! We are truly grateful for all that you do!

When asked what her greatest youth and/or family success story was, JPO Cintina Daniels replied, "Not too long ago, I had a family with a little girl that was acting out. She happened to be the daughter of a person that I was also a probation officer for when she was younger. When the girl was brought to JDC for an offense, we sat down and talked about all of the things she wanted to do and the girl was aware of her own mother's past. Providing them this chance to connect and through Strengthening Families, a family counseling program, the family was able to get back to a typical routine and the little girl is doing wonderfully. While mental health was not an aspect in this case, overall understanding why the kids act out is especially important."

JPO Daniels gave some insight into what drives her to help youths in her community by stating, "School is always a huge priority, and something we encourage for the youth, but my drive is mostly patience. With those with mental health disabilities and not, patience is really important and in school understanding the programs offered and parents having a better understanding of how their child is performing are really important to that student being successful. I really enjoy being helpful to my families overall, especially those that may be acting out because of other things related to mental health and making sure they get the help they need."

She finds that helping others is the most rewarding aspect of working as a JPO. We are so grateful for all that JPO Woodruff has achieved in her community!

JPO Stephanie Malburg is a talented individual who strives to go above and beyond to help the youths and families of Lamar County. When asked what inspires her to work with youth in her community she replied, "Today's youth are our future world leaders and if we don't equip them with the tools they need to be successful and reach their full potential, we are doing a disservice not only to them but to society." JPO Malburg describes the most rewarding aspect of her job as, "Helping the youth develop goals and witnessing them reach those goals to unlock their full potential. Telling them they can be more than what they are right now and their negative behaviors don't have to define who they are as people. "

When asked how she engages caretakers she replied, "Many families are often intimidated by the juvenile justice system, especially if they are unfamiliar with [it]. They are often times anxious about their child's future. If families are unfamiliar with what to expect and are not provided essential information about the process, the likelihood they will cooperate and participate is low. It's my job as a Probation Officer to provide them with information and support to help them become knowledgeable...The most successful cases are the ones in which the child's parents are actively involved in their probation. When I have very supportive families, the kid is going to make it. I have to have the parents on board."
